

Alumni Spotlight: Judicious Brothers

Brother I. Beverly Lake, Jr. was born in Raleigh and grew up in Wake Forest, North Carolina. Lake graduated from Wake Forest University and the Wake Forest University School of Law. He served on active duty in the United States Army as an Intelligence Staff Officer from 1956 to 1958 and in the United States Army Reserve from 1958 to 1968. From 1989 to 1992, he served in the North Carolina State Militia as State Staff Judge Advocate. Justice Lake has attended the National Judicial College, completing a comprehensive course of study for judges nationwide.



Justice Lake began his legal career in 1960 in the private practice of law in Raleigh. In 1969, he was appointed Assistant Attorney General in the North Carolina Department of Justice and served in this capacity until he was promoted to Deputy Attorney General in 1974. While in the Department of Justice, Lake represented the Revenue Department and was Director of the Public Utilities Division of the Attorney General's office, representing the public in all utility rate cases. He represented the University of North Carolina at Chapel Hill in the \$60 million sale of all its public utilities.


Justice Lake was elected to the North Carolina Senate twice, serving from 1976-1980. He represented Wake, Harnett and Lee Counties and was ranked one of the ten most effective Senators in the North Carolina General Assembly in 1979 by the Center for Public Policy Research. Justice Lake chaired both the Senate Judiciary II Committee and the Public Utilities and Energy Committee.

In 1985, Governor James G. Martin appointed Lake Special Superior Court Judge, and he served in this capacity until 1991. While a Superior Court Judge, he held both criminal and civil court in 63 of the 100 counties in the state. In 1992, Governor Martin appointed Lake Associate Justice of the Supreme Court of North Carolina, and in 1994, Lake was elected to the Supreme Court for a full eight-year term.

Committed to service in his community, Justice Lake has long been active in local civic organizations. He has been a member of the Raleigh Junior Chamber of Commerce; the Raleigh Executives Club; the Weswyn Club of Raleigh, where he served as President; and the Raleigh Chamber of Commerce. He presently serves on the Advisory Boards of the Occonechee Council, Boy Scouts of America; the School of Law, Wake Forest University; and the Southeastern Baptist Theological Seminary.

As for his experience with Lambda Chi, Lake comments "I greatly benefited from my undergraduate days at Wake Forest as a Lambda Chi brother. My brothers in Lambda Chi were family and taught me much about peer interaction in those formative days, and enhanced my overall campus involvement. I am very close to them today."

Brother John C. Martin, a 1965 graduate of Wake Forest University, is currently serving as a judge on the North Carolina Court of Appeals. Justice Martin has distinguished himself in many aspects of life since receiving his JD from WFU in 1967, including outstanding contributions in the legal



field, military service, and community involvement. Justice Martin worked with an independent law practice for his first several years after receiving his JD and then went on to work at a North Carolina Superior Court. Since then he has worked with another independent practice before returning to the Court of Appeals, which he worked at in the mid-80's. Justice Martin is a member of several professional organizations, including several county Bar Associations. He also found time to be a 1st Lieutenant in the U.S. Army from 1967 to 1969. In addition, Martin has found time to hold positions on the Board of Visitors and the Alumni Council at Wake Forest.

Justice Martin has also been involved with the Administrative Boards at several churches in the

Raleigh-Durham area. His distinctions include being named the 1976 Durham “Man of the Year”, and has appeared on lists of “Who’s Who in America” as well as “Who’s Who in American Law”. Brother Martin is married to Margaret Rand Martin. www.aoc.state.nc.us/www/copyright/coa/bios/martinj.html †

Reflections of a Dedicated Alum

When the Tauker asked me to write my reflections of the experiences as a Brother in Theta-Tau, I realized that that it has been 42 years since I entered Wake as a freshman. I followed my two brothers the oldest of which had graduated that Spring and the older, Mike, was a Sophomore and a member of LXA. My first experience with LX was a visit from Mike and David Tschorn inviting me to drop by the house and meet the brothers. From that day forward, the Brothers took time to get to know all of the “rushees” and involved us in the social structure of the fraternity. By the time first semester was over, the “rushees” had formed a bond among themselves that would last a lifetime.

One of the biggest events of my life was the Initiation. Unless you’ve been there, you can’t explain it. The Initiation set high ideals and principles for us to live by. Over the years, those memories of the initiation have reinforced and been part my spiritual growth.

Over the years, small groups of Brothers would meet for small reunions. It was several years ago that I received a Tauker and realized that the colony was reaching out to the alumni to inform the alumni of its efforts to re-establish LX. As I thought about what a great time my fraternity experience had been, I realized how much I missed seeing my Brothers.

By contacting Hi Pi Dan Anthony and High Alpha Sam Newlands, I was encouraged to pursue a reunion that would involve the interaction of the alumni and the colony. After discussing a reunion with several brothers, we decided to have a small reunion of the Brotherhood from the 50’s and 60’s. The reunion was by all standards a success. Little did I expect that it would be such an emotional experience for all of us. The bonds of Brotherhood that had been formed 42 years ago had stood the test of time and grown more precious.

That reunion was the formation of the TTAA. With the help of many Brothers, the association was

formed with the belief that a strong alumni association can be of strength to the Chapter. Within months the Brothers responded by joining. Nationals had denied the colony Chapter status because they had not met a standard of at least 40 members. One of our first goals as an association was to contact National and seek a waiver of this standard based on the excellent record of the colony in other areas. The alumni efforts were successful and the Grand High Zeta approved the Charter to be formalized this November 3rd.

As some of us have grown older and found our health slipping away, the prayers and support of our Brothers is comforting and a continuation of the caring for each other that started 42 years ago. †
